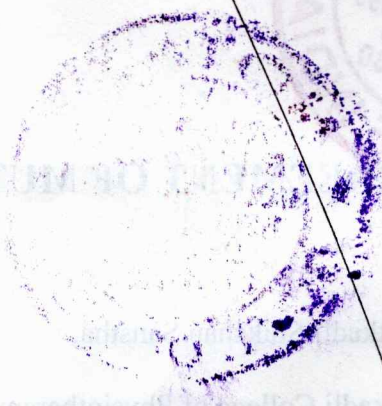

1. The Second Party will allot the mentioned Ambulance Vehicle for anytime use to the First Party for all its emergency uses, as per this contract on priority basis.
2. The said service will be provided on On-Call basis, throughout the year at 24/7 time slot
3. On availing this service, the incurred trip expenditure will be calculated based on the individual trip sheet utilized.
4. The costing of the trip includes – Taxi, All Utilities (Monitor, Oxygen, CRP, Defibrillation, Emergency Medical Service, Other Hospital Accessories used, etc.) and the Driver Fee for the specific utilized trip (based on the distance covered).
5. All utility charges will be paid through any Nationalized Payment Banks Online Transfer after duly checking the trip sheet and signed by the responsible representative of the First party and Second Party.

Further and any other additions or deletions or changes or termination can be made with mutual and verbal consent between the two parties.

On any instance if there is a disturbance noted between the two parties and / or the First Party during the provision of this service, at any time this agreement can be deemed Null & Void by the Second Party. At the same time if the service has to be terminated by the First Party a clear written instruction should be produced at least 15 days prior for consideration.

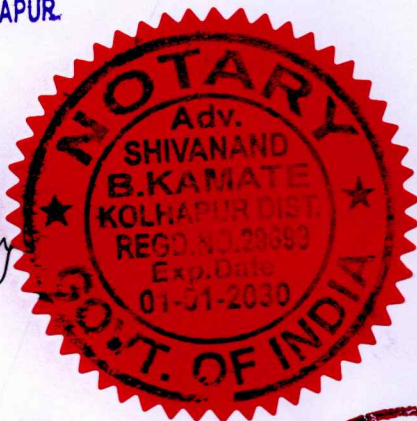
